Meeting called to order at 4:30 PM. by Chairman Meade.

- 1. MINUTES OF PREVIOUS MEETINGS: Lundstrom made a motion to approve the April meeting minutes, Freiberg seconded.
- TREASURER'S REPORT: \$333,756.26 spent in April. Lundstrom is going to change the "Bond Fund" to the "Asset Reserve" fund. Final invoice from cord was paid for \$147.406.00. Documents provided as to the other financials. Freiberg made a motion to approve Treasurers Report. Lundstrom second. Motion carries unanimously.
 - A. Audit: Lundstrom made a motion not to exceed \$17,000 for the audit of 2024-2025 financials. Freiberg second
- 3. GUESTS: None.
- 4. COMMUNICATIONS AND CORRESPONDENCE: Various thank you cards were received throughout the month.
- 5. PERSONNEL UPDATES: We are at 58 total personnel, 49 available for emergency response. (3 support staff, 4 administrative, 2 chaplains) Also, for reference we have an additional 30 personnel that work only the contract staffing side of operations. Two minor injuries as a result of the IFSI academy. Both currently appear that they won't grow into something bigger. Lundstrom made the motion to accept resignation of Ken Schwartz. Freiberg second. Roll call vote: Lundstrom-yes, Meade- yes, Freiberg yes. Motion carries unanimously.
- 6. CHIEF COMMENTS: Call volume through the end of April 2025: 211 calls for the month, 825 for the year through April. We are at 7.03 calls a day for April, and 6.875 per day for the year. The OSFM small equipment grant items have been ordered and we have the money from the state. Flashover training that the board approved was a success. Out of 96 possible "slots" we had 74 attendees, 30 were outside agencies which will offset our expenses by \$2,250 once they've paid their invoices. The \$50K from Stadelman is currently held up in a bond being issued to fund it.

- 9. TRAINING UPDATE: RIT Training, EMS Training, continuing new driver training.
